Superintendent Robertson gave an update on projects around town and working with contractor to get grass finished around the new bridge.

Superintendent Rieck reported that the LL Pelling estimates came in today along with a couple of bids for stump grinding. Funds for street sweeping won't be available until July 1, 2024.

The library reports were reviewed. Usage on Sunday is people on the library internet.

Bill Bruce is willing to meet with the council regarding sidewalk discussions. Three properties selected for sidewalk replacement. State city intentions and get homeowners who receive letters intentions so we can move forward with replacement.

Employee reviews are to be held 5-17-2024 at 9:00am.

Vogt motioned for the city to donate \$250.00 for the 4<sup>th</sup> of July fireworks, seconded by Reeves. A roll call vote was taken, all ayes except for Travis abstained.

Hepker motioned to approve the Pearl Street Social Club cigarette permit, seconded by Travis. All ayes except for Reeves nay.

Hepker motioned to approve Roy's cigarette permit, seconded by Harvey. A roll call vote was taken, all ayes, except for Reeves, nay.

The nuisance courtesy letters were reviewed by the council and they requested the Chase Meyers property be removed due to their fire.

Shadoe will communicate with Steve at ECICOG to review current and previous letters and bring back to council at the May 21<sup>st</sup> meeting.

Vogt motioned to adjourn, seconded by Reeves. All ayes.
